RE: July Budget Revisions

Notable changes to the budget processed during the month of July 2023 are as follows:

UNRESTRICTED:

Budget revisions processed reflect no change to revenue. Significant changes to expenditures are as follows:

- \$50,000 Increase to services with XAcademy for the Robotics Initiative
- \$22,500 Increase to services with Community Action Board to support Youth/Young Adult Employment services

Budget revisions processed in July 2023 had an overall decrease to the unrestricted fund balance in the amount of \$87,293.

RESTRICTED:

Budget revisions processed reflect an increase in restricted revenues in the amount of \$15,000 and an increase in expenditures in the amount of \$29,700. Significant changes are as follows:

- \$150,000 Increase in Contract Services for a professional services agreement to obtain School Psychologist Services for Alternative Education with a similar decrease in salaries and benefits originally budgeted as a personnel vacancy
- \$15,000 increase in revenue and corresponding expense related to a grant awarded to Student Support Services for Positive Behavior Interventions and Supports.

Budget revisions processed in July 2023 had an overall Decrease to the restricted fund balance in the amount of (\$14,700).

PACHECO BILL COMPLIANCE:

There were three professional service agreements/contracts in excess of \$25,000 that required budget revisions be processed during July 2023.

Contracts with XAcademy and 3Chords Inc/TherapyTravelers LLC, for a maximum of \$50,000 and \$150,000 respectively, were previously disclosed and approved at the July 20, 2023 Board meeting.

A contract for professional services with Community Action Board of Santa Cruz County for a maximum of \$45,000 will provide employment specialist services to youth and young adult students participating in the Alternative Education, Suenos, and Career Advancement Charter programs. Alternative Education unrestricted funds will be utilized for up to 50% of this contract, a maximum of \$22,500.

Business department staff continue to communicate and work closely with department staff and managers to review revenues, expenditures, and budgets for 2023-24 as we progress with the 2022-23 fiscal year-end close processes.

RESOLUTION #23-27 RECOGNIZING NATIONAL SUICIDE PREVENTION MONTH

WHEREAS, suicide is the 9th leading cause of death in the United States and the 2nd leading cause of death among individuals between the ages of 10 to 34; and

WHEREAS, according to the Centers for Disease Control and Prevention (CDC), one person dies by suicide every 11.7 minutes, resulting in nearly 45,000 deaths each year in the United States; and

WHEREAS, suicide is the only leading cause of death in the United States that has increased every year for the past decade; and

WHEREAS, it is estimated that there are over 1,200,000 suicide attempts each year; and

WHEREAS, there are an average of 130 suicides each day in the United States; and

WHEREAS, suicide is preventable, as 9 out of 10 suicide attempt survivors do not go on to die by suicide; and

WHEREAS, the stigma associated with mental health conditions and suicidality works against suicide prevention by discouraging persons at risk for suicide from seeking life-saving help and further traumatizes survivors of suicide loss and people with lived experience of suicide; and

WHEREAS, September is recognized as "National Suicide Prevention Month" in the United States which overlaps with World Suicide Prevention Day, September 10th, recognized internationally and supported by the World Health Organization.

THEREFORE BE IT RESOLVED, that the Santa Cruz County Office of Education is committed to:

- 1. Recognizing suicide as a preventable national, State and local public health problem;
- 2. Supporting the declaration that suicide prevention should be a priority;

- 3. Supporting the designation of September as "National Suicide Prevention Month";
- 4. Developing and implementing strategies to increase access to quality mental health, substance abuse, and suicide prevention services.

- 6. Participating in suicide prevention initiatives by working with local organizations that listen to and support those who are at risk for suicide.
