




This chart shows the total general purpose revenue Bonny Doon Union Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Bonny Doon Union Elementary School District is \$2,725,693, of which \$2,182,260 is Local Control Funding Formula (LCFF), \$189,542 is other state funds, \$248,557 is local funds, and \$105,334 is federal funds. Of the \$2,182,260 in LCFF Funds, \$49,474 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Bonny Doon Union Elementary School District is projecting it will receive \$49,474 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Bonny Doon Union Elementary School District (BDUESD) is a single-school, community-funded (Basic Aid) district. BDUESD has a long history of strong academic performance. Currently, the California School Dashboard displays BDUESD as .1 points above standard for English Language Arts and 4.7 above standard for Mathematics. An analysis of last spring's CAASPP scores reveals a large number of students who are within points of meeting standards in both the ELA and Math. Recently, BDUESD was recognized with the state's Pivotal Practice Award for its work supporting students. Bonny Doon is a recent Gold Ribbon School and a Certified Green School. The school benefits from a supportive and involved community of parents, students, staff, and Bonny Doon residents. Absenteeism is a concern. With COVID-19 playing a major role in absenteeism, as well as increased awareness from our community partners to keep their students home when feeling ill, students are missing school for longer durations of time.

Student enrollment in 2023/2024 is 94 in grades TK-6. Our enrollment has declined since COVID-19 and the wildfires. Enrollment fluctuations remain an active discussion with the school board to make certain our programs and facilities meet our student needs. We are committed to continuing to provide our students with a well-rounded, high-quality academic program, even during this time of enrollment fluctuations and recessed funding. Regardless of funding, we have maintained our focus on providing a rigorous, well-rounded educational experience.

Bonny Doon School has one statistically significant subgroup, white. In the 2023/2024 school year, the school has two English Learners. The school currently does not have any Foster Youth students. The superintendent is a member of the Foster Youth Services Local Advisory Board and has signed the Foster Education Initiative MOU agreeing to collaborate with that team whenever one or more Foster Youth enrolls in the school. Any other subgroups (Special Education, for example) are included in all goals and services related to pupil outcomes, pupil engagement, and conditions for learning.

All state priorities and required metrics are included with the exception of those that do not apply to our TK-6, single-school district (A-G course access and high school graduation rates).

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Looking at the state's Dashboard, there are a few highlights and areas for concern. Our suspension rate remains in blue, maintaining 0 suspensions. Several local indicators are reported as "Met" on the Dashboard: Teachers Instructional Materials and Facilities Parent and Family Engagement and Local Climate Survey.

Our ELA CAASPP scores are shown as yellow. While our students perform at the state average, there was a decline of 26 points from the prior year. Math is also listed as yellow and maintained performance. Standardized test scores are volatile from year to year due to the small number of students testing, and we can do better. Increased efforts with local benchmark data will greatly support our instruction and student success.

Chronic Absenteeism is a significant concern and listed as red on the state's dashboard. Over the last year, we experienced an 8.7% increase in students falling into that category (39.7%).

Bonny Doon Elementary's intervention support has been particularly effective for our primary grade students. Students in grades 1-3 were successfully served and exited from intervention support. Of the 17 students served, 8 of them exited. Intervention efforts with our 4th-6th grade students were not as successful due to an increase in our English Learner enrollment, causing our intervention teacher to increase her allocation of time to meet the needs of our new language learners. Instructional aides, in collaboration with the classroom teachers provided intervention support in the classroom.

Our school continued its investment in Social and Emotional Counseling for our students. Capacity exceeded service provider caseload limits, so alternative approaches to support students in need were implemented such as calming spaces, the adoption of an online platform with live support staff, and frequent, individual staff member-to-student check-ins.

Overall, we made progress with communicating and engaging our community. Student attendance is showing a slight increase from last year as the effects of COVID-19 are becoming less dramatic. Our parent survey shows 100% of our community "receive timely communication" from the school, and they appreciate the continued effort to keep them informed. This year, we increased the number of opportunities for parents to provide input with more frequent coffee chats, afternoon teas, and evening events. At least two times each month, there were events to solicit parent input and feedback. With our declining student population, we managed to increase the number of parent and community volunteers at our school. This year, we saw a 7% increase in volunteers at school.

Student surveying indicated that they "like school" and "feel connected" to staff. Students have expressed interest in increasing recess activity options, which will be addressed outside of our LCAP.

Staff were able to attend a variety of professional learning. Teachers attended conferences in subject-specific learning (mathematics, physical education, reading instruction) as well as conferences for job-specific roles (learning and the brain, executive assistant training, standardized testing training, district/school leadership). Following the professional development, staff shared key learning and resources to support our collective efforts.

With each of our stakeholder groups, we heard common themes. Our community (staff, parents/guardians and community) expresses a continuous focus on rigorous and engaging academics. Our parents/guardians expressed support for the creative and thematic approach to teaching; particularly the inter-disciplinary approach. Additionally, our focus on improving math understanding continues to be an area of interest. Our community partners shared their support of our TtP (Teaching through Problem-solving) approach to math instruction, stating that the individual, partner and whole-group methods help their students to deepen understanding. While social and emotional learning and

supports has been a long-standing focus, our recent stakeholder feedback demonstrates an increased awareness. Our parent community is particularly supportive of our focus on community.

Additionally, the community shared feedback related to the school's facilities, specifically related to power redundancy. The Bonny Doon community experienced extreme heat, snow, cold and rain this year. Power outages do not force the school to close, but they leave the school without heat and ventilation. The BDUESD Board of Trustees has taken this issue up as a matter not included in this LCAP due to the significant cost.

The staff at Bonny Doon Union Elementary School District recognize the importance of support for our foster, low-income and English language learners. Our intervention staff and instructional aides prioritize providing additional and supplemental supports for this special population of students on our campus. BDUESD estimates that its Minimum Percentage Proportionality is 12%. The actions and services described within this plan have been principally directed to support all students with a focus on the needs of the unduplicated student groups. Examples of actions and services selected to specifically supplement the support and instructional resources offered to unduplicated students in 2024-25 include Intervention teachers, instructional aides, professional learning, and family partnerships. The actions and expenditures in this LCAP meet the requirement to increase or improve services for unduplicated students by 3.77%
