Background: As recruitment for Senior Instructional Aides for the 2025-2026 school year has begun, the department noticed that the current job description reflects an outdated way to refer to the needs of students with disabilities. The California Commission on Teacher Credentialing (CTC) now calls their credential Extensive Support Needs (ESN) to refer to the student's individual needs rather than their specific disability category. Therefore, a title change with minimal revisions is being requested to better align with the terms that are now used across California schools.

The newly proposed title is Senior Instructional Aide, Extensive Support Needs. As a title change with minimal revisions is being added to an existing classification, the department is requesting to have these changes approved at a first reading. Salary allocation would remain the same. This constitutes a first reading.

Since these updates have been reflected in the C.S.E.A union contract language, these changes should now be updated in the Merit Rules as well. This constitutes a first reading.

Motion: To approve the Merit Rule revisions for Article 7.105, Bereavement Leave and the Merit Rule addition of Article 7.106, Reproductive Loss Leave at a first reading (Miller/Lane).
