## RESOLUTION #25-46 IN REMEMBRANCE OF ROSE FILICETTI

**WHEREAS**, the Santa Cruz County Board of Education mourns the passing of former Trustee Rose Filicetti, whose steadfast commitment to public service, education, and community well-being left a lasting legacy across Santa Cruz County and beyond; and

WHEREAS, Rose's impactful career spanned government, education, banking, nonprofit leadership, and community organizing; and

**WHEREAS,** upon moving to Santa Cruz County, Rose soon emerged as a dynamic and influential community leader, dedicating herself to advancing opportunities for youth and improving the systems that support them; and

WHEREAS, Rose was a steadfast champion for digital equity across the Monterey Bay region, including through her leadership as a founding board member of nonprofit Digital NEST; and

**WHEREAS**, recognizing the need for stronger coordination among local organizations, Rose founded and led Nonprofit Connection Santa Cruz County — building a countywide network that strengthened relationships, empowered nonprofits, and streamlined support for students and families; and

**WHEREAS,** Rose served as the Area 4 Trustee on the Santa Cruz County Board of Education from 2017 to 2023, representing the communities of Live Oak, Soquel and Capitola and providing thoughtful leadership rooted in equity, public service, and collaboration; and

**WHEREAS**, during her tenure on the Board, Rose served as Vice President in 2020 and President in 2021, leading the Board through a critical period for public education while championing efforts that uplifted equity for all; and
