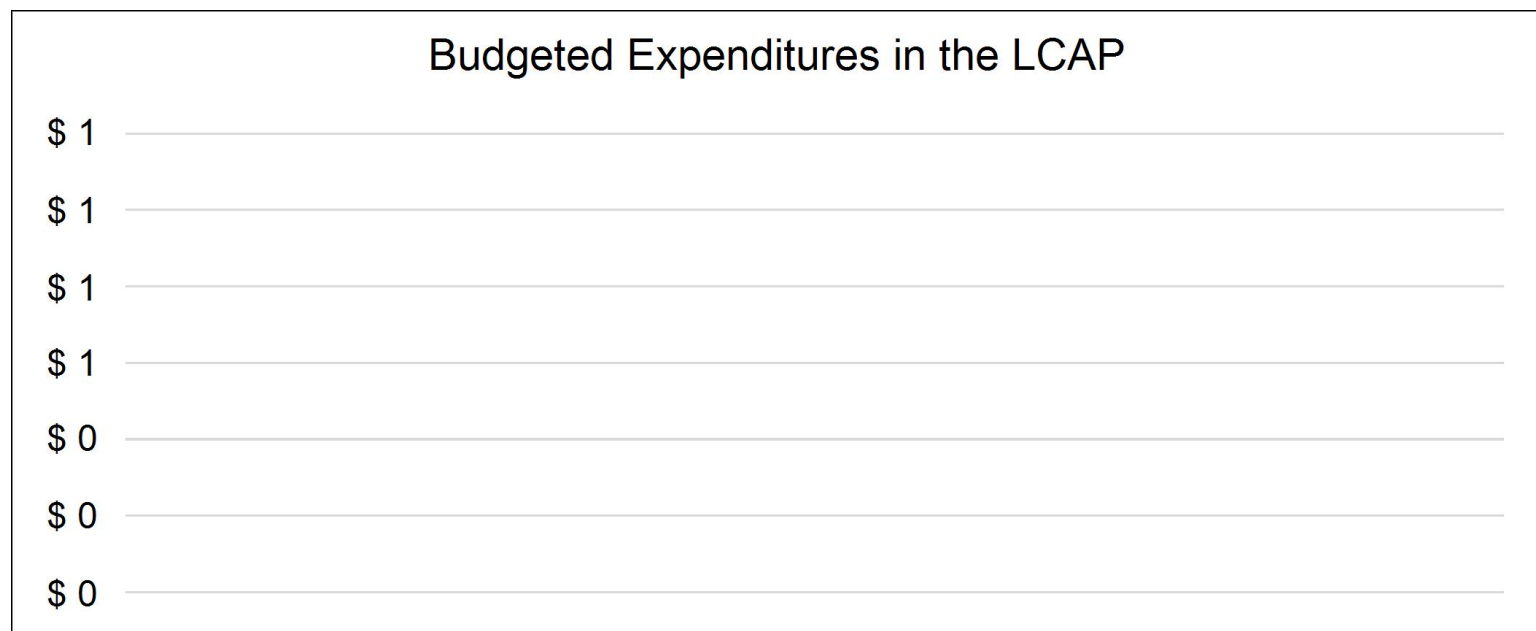

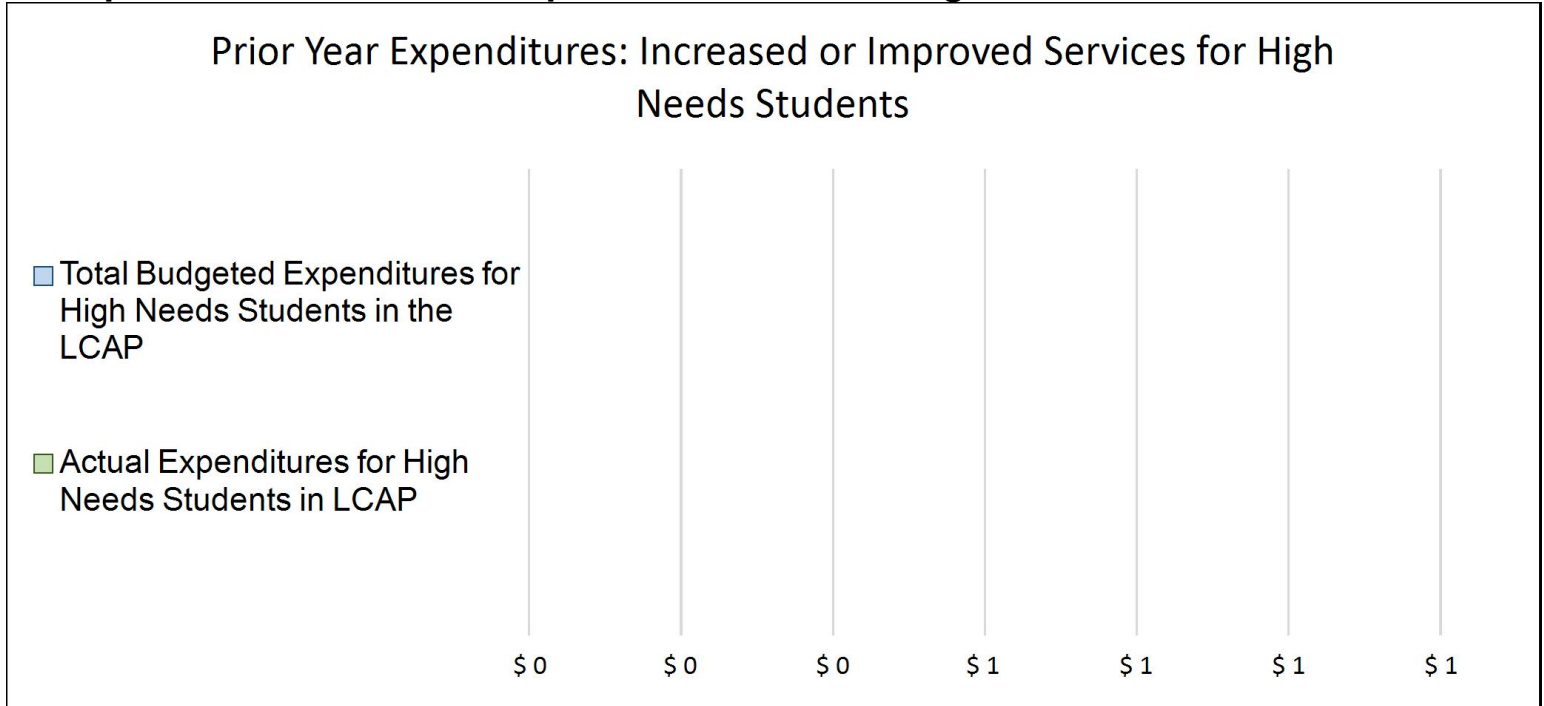

## Plan Summary [2025-26]

### General Information

Founded in 1995 by a group of key Santa Cruz area business leaders and chartered by Santa Cruz City Schools, Delta is an accredited, free, public charter and serves all students regardless of socioeconomic status. Delta serves approximately 120 students in grades 9-12 whose needs have not been met by a traditional school model. Through strong relationships, Delta builds a safe, inclusive, and caring academic community. Small classes, varied programs, and engaging curricula empower students and prepare them to successfully navigate life beyond high school. Situated on the Cabrillo Community College campus, Delta is in a unique position to partner with Cabrillo and help our students seamlessly transition to college after high school. While we recognize that college may not be for everyone, and therefore do not adhere to A-G requirements for graduation, it is our goal to keep all doors open for students, and we encourage students to take at least one Cabrillo class before graduating. To prepare students for college and career, our teachers and staff emphasize our Grad Skills: identity and self-awareness, resilience, critical thinking, communication, collaboration, and work habits. Student success is supported by a qualified staff: a full-time Superintendent/Principal, a 100% Lead Teacher of College and Career, a 100% student support specialist, a 100% resource teacher, an independent studies teacher, and 7 credentialed content-area teachers. In addition, Delta contracts for the services of a mental health counselor, a certificated school nurse, an art teacher, and a school psychologist. Classified staff includes an office manager, an attendance clerk, and two para-professionals.

Delta serves students through three programs that provide the structure and flexibility to obtain to a diploma through rigorous course work, concurrent enrollment in college classes, and the opportunity to explore career interests. The Direct Instruction program is a classroom-based model and includes a period each day of tutorial or homework support. The Guided and Independent Studies programs allow students to access their diplomas through an individualized course of study. Independent Studies students meet weekly with their advisor while

committing to 20 hours of independent work a week. Guided Studies students meet daily with their advisor for a more structured approach. The flexibility of our programs provides access to students who have additional outside-of-school responsibilities, need to recover credits, want to accelerate their learning at Cabrillo, or have barriers to their educational success including mental health concerns or other challenges that impact attendance and engagement. The staff at Delta is trained in Trauma-Informed Care and work closely with the social-emotional counselor to identify and strategically respond to students who are struggling.

Delta High School is its own Special Education Local Education Agency (LEA). As our authorizer, Santa Cruz City Schools provides support with Delta's lunch program, assessment, Infinite Campus (student information system), and ADA apportionment. Santa Cruz City Schools also provides consultation for the principal in the areas of finance and human resources. A representative from the district's board serves on Delta's governing board. Delta's board consists of 6 members: 1 Santa Cruz City Schools representative, 1 Cabrillo Community College representative, 1 parent representative, 3 alternative educator/business persons, and 1 community/business members.

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Delta's California School Dashboard is less illuminating than most traditional school dashboards, as the Dashboard does not provide indicators for statistically insignificant data and our population is too small to yield that significant data. Nevertheless, Delta consistently examines this data and identifies strengths and areas for growth. Strengths include having a higher than-state average graduation rate at 92.3% as well as a low suspension rate due to a stronger focus on restorative justice practices over traditional discipline practices. The CA Dashboard data indicates that only 11% of Delta students are college ready, however, both semesters in 2024 we had approximately 50% of our students dual enrolled in a Cabrillo class and at least 65% of our 2024 seniors graduated and went on to community college, which we consider a strong local indicator for college preparedness.

Delta acknowledges that our math and English scores have declined, chronic absenteeism remains a concern, we have teachers teaching out-of-field, and we would like to continue to increase college and career readiness. We maintain a standard of continuous improvement and are focused on the following goals for the next three-year cycle:

- Develop systems and supports that build resilience, disrupt chronic absenteeism, and increase attendance.
- Develop and provide academic and social-emotional supports that engage and empower students with the skills necessary to access post-secondary college/career opportunities.

Parents	Delta distributed a survey in December 2024 and closed it in January 2025. 65% of parents participated in Delta's annual Parent LCAP Survey, which included questions about academics, social-emotional learning, staff-student connectedness, safety, and facilities. Additional open-ended questions regarding parent recommendations for improvement were also included. Delta held a parent meeting in February 2024 to review the data and garner additional feedback.
Staff/Administrator	Delta distributed a survey in December 2024 and closed it in January 2025. 75% of staff participated in Delta's annual Parent LCAP Survey, which included questions about academics, social-emotional learning, staff-student connectedness, staff connectedness, safety, and facilities. Additional open-ended questions regarding recommendations for improvement were also included. Delta's staff reviewed and discussed the results in a staff meeting in March 2024.
Students	Delta sent out a survey in December 2024 and closed it in January 2025. 65% of students participated in Delta's annual Parent LCAP Survey, which included questions about academics, social-emotional learning, staff-student connectedness, safety, and facilities. Additional open-ended questions regarding student recommendations for improvement were also included. Delta's principal brought the data to the student leadership class in March, and they discussed the results and gave feedback.

- \*79% of parents surveyed indicated that Delta's small class sizes and extra support were a reason for enrollment (goal 1 and 2, all actions)
- \*62% of parents surveyed indicated that Delta's connection to Cabrillo Community College was a reason for enrollment (goal 2, all actions)
- \*42% of students surveyed identify the Directed Studies class as one of the reasons students succeed at Delta (goal 2, action 1).
- \*60% of parents and 50% of students cite attendance as a barrier to school success (goal 1, action 2)
- \*50% of our students who took the survey said they accessed our social-emotional counseling services (goal 1, action 1)
- \*65% of parents indicated that they would like to see continued college and career opportunities for their students (goal 2, all actions)
- \*70% of teachers indicated that they would like to work toward increasing students' academic success (goal 2 action 6)
- \*30% of teachers and staff indicated that they would like to learn more about authentic assessment and curriculum development (goal 2, action 6)

An explanation of why the LEA has developed this goal.

By design, Delta is a school for students who have not been served by a traditional school model. In some cases, students were school-avoidant and chronically absent before enrolling with us and continue to be chronically absent at Delta while they acclimate to our systems and supports. Delta's Care Team closely monitors student data and at any given time, about 40% of Delta students are considered chronically absent by federal standards. Eventually we do see a turnaround for most students, but as they improve, graduate, and move on, a new group enrolls and we begin this process again. This cycle repeats year after year, requiring Delta to maintain this goal.

## Goal Analysis [2024-25]

Delta made significant progress in implementing all three planned actions while adapting to emerging needs and challenges throughout the year. We had no implementation challenges, modifications, or non-implemented actions.

### Successful Implementation:

- Action 1.1 Support for Chronically Absent Students: Delta's Care Team met regularly to strategize individualized support for chronically absent students.
- Action 1.2 Access to social-emotional support and counseling: Delta's student support specialist increased targeted outreach and increased student contacts by 10% from the 23-24 school year. This is 5% away from our goal of 65%.
- Action 1.3 School safety: 93% of students surveyed reported feeling safe or mostly safe at school. This surpasses our 3-year goal by 3%.

Delta's small-team and school-wide efforts to support the safety and social-emotional well-being of students have been highly effective in maintaining and, in some cases, surpassing our goals.

We made minor adjustments of the language in our action 1.2 and 1.3 to align with accessible data. Initially, we were using data specifically focused on LGBTQI students and could not isolate that data specifically from that population based on the structure of our survey. As such, we will be using whole-school data as opposed to LGBTQI+ students.

## Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Delta made significant progress in implementing most actions while adapting to emerging needs and challenges throughout the year. We had no non-implemented actions, but did modify actions 2.2 - 2.4 to reflect a shift in our focus on student progress.

### Successful Implementation

- Action 2.1 Tutorial Support: Delta's instructional supports hinge on our tutorial class, Directed Studies. With a targeted focus on Government and Economics, students went from a 30% pass-rate without credit recovery to a 67% pass rate, surpassing our 3-year end-goal by 27%.
- Action 2.5 Dual Enrollment and Matriculation Support: 73% of Delta seniors completed Cabrillo College's Running Start process. This surpasses our 3-year end-goal by 3%.
- Action 2.6 College, Career and CTE Support: 50% of students participated in college/career activities, a 5% increase from our baseline goal.
- Action 2.7 Highly-qualified Teachers: One teacher obtained a single-subject credential; one teacher obtained a local authorization. There is no data from the state available.

### Implementation Modification

- Action 2.2 - 2.4: Delta initially planned to create and deliver in-house assessments to have clear data on student progress (Action 2.2), which would then inform the process of choosing math and English enrichment curriculum (Actions 2.3 and 2.4). For a variety of reasons, the Delta staff determined that a state-approved assessment would be more appropriate for our goals to support student growth, particularly in English and math. Delta spent the 24-25 school year vetting and choosing a state-approved assessment and exploring math and English support curriculum.

There were no significant material differences in budgeted expenditures or services.

Overall, Delta was successful in implementing this goal, as we approached, met, or superseded our target goal. In the areas of assessment, Delta staff determined that our plan to develop and launch in-house assessments needed to shift toward seeking more formal, state-approved local assessments. We determined that this would help with our authorization, but more importantly, would assist us with identifying learning gaps and more specific ways to address those gaps.

For the coming year, Delta intends to fully implement goals 2.2, 2.3, and 2.4 through choosing an appropriate assessment and math and English support curriculum.

  - This amount is the total of the Last Year's Planned Expenditures for Contributing Actions (LCFF Funds).

  - This amount is the total of the Estimated Actual Expenditures for Contributing Actions (LCFF Funds).
- **Difference Between Planned and Estimated Actual Expenditures for Contributing Actions (Subtract 7 from 4)**
  - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4).
- **5. Total Planned Percentage of Improved Services (%)**
  - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
  - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.
